An application (attached) has been approved and brought forward by Program Committee for the consideration and approval of Quaker Life Council. After some discussion, members of the council were clear that we are not ready to come to unity on this application at this time and needed further information before full consideration could be given. The Clerk was requested to contact the Clerk of Program Committee to request further information about the collaborative and the General Secretary was also requested to secure information, particularly about ramifications of the proposed relationship with another not for profit organization (Heeding

God's Call) in advance of the October council meeting. This item will be reconsidered in the October meeting of the Council.
