

Philadelphia Yearly Meeting Quaker Life Council Approved Minutes October 21, 2023

1. Worship & welcome

Meeting opened in silent worship at 11:15 AM.

2. Review & approval of minutes

- The Council approved the minutes for September 2023 with no changes.
- The clerk adjusted the agenda to shift Program Committee report to November's meeting.

3. <u>Collaborative on Ending Gun Violence</u>

- Last month, the council reviewed the application from the "Heeding God's Call to End Gun Violence Collaborative" and forwarded some questions through the Program Committee. The Program Committee shared the comments to the collaborative. Christie Duncan-Tessmer clarified that legally a member from the 501(c)(3) nonprofit organization, Heeding God's Call, could partner with the collaborative, as long as the group itself is not a named member, nor is the collaborative a branch the larger group, Heeding God's Call.
- The new Collaborative was approved, upon the condition that the official members be connected directly to or "planted in" Philadelphia Yearly Meeting.

4. Sessions Coordinating Committee

Sessions Coordinating Committee (SCC) shared a proposal for 2024 annual sessions:

• Friends General Conference is meeting this year at Haverford College, for the first me in 100 years. SCC had a proposal for just this year. SCC suggested that we attach Annual Sessions to one side of the FGC gathering and extend Continuing Sessions. If PYM had a short Annual Sessions in July, Continuing Sessions would extend to more than one day for a year. The total amount of me in sessions would remain the same. SCC proposed either using the fiscal year and extending the Fall 2024 and Spring 2025 Coming Sessions or using the calendar year and extending the Spring 2024 and Fall 2024 Continuing Sessions.

- The Council approved the SCC proposal for the one year. The Council encouraged SCC to plan a shortened July hybrid Annual Sessions after the FGC Gathering, on July 6 (and perhaps July 7) on the Haverford Campus. The clerk's team shall provide an appropriate agenda for the time and place. The Council decided to implement the 'calendar year' model that would extend Continuing Sessions for Spring 2024 and Fall 2024.
